## Request to park a motorcycle/scooter on the school site

**YOU MUST HOLD A VALID LICENCE TO APPLY FOR A PERMIT. IF YOUR APPLICATION IS SUCCESSFUL, YOU WILL BE ASKED TO SHOW BOTH YOUR LICENCE AND YOUR CERTIFICATE OF MOTOR INSURANCE.**

- 1 Permission to bring a motorcycle/scooter to school is given on a provisional basis only, and priority will be given according to need. Permission will be withdrawn if parking space for students is required for other purposes.
- 2 Extreme care must be taken on entering and leaving the school premises. Students must only use the Station Road entrance, ie **no entry or exit from the Leisure Centre end**. The maximum speed limit is **5mph**. Reckless or careless driving will lead to the withdrawal of the privilege of bringing a motorcycle/scooter into school. For safety reasons, students should not drive their motorcycle/scooter out of the car park between 3.00 and 3.30 pm.
- 3 Students can only park in the motorcycle/scooter area by the Site Team Workshop. They must not park in the main car park, fire muster point/gravel area, disabled bays or in delivery areas. Students must not park in the Leisure Centre car park, where unauthorised vehicles may be reported to the police and/or clamped.
- 4 Responsibility for students driving to school by motorcycle/scooter rests with themselves and their parent/carer.
- 5 Permission to bring a motorcycle/scooter to school is given on the understanding that it will simply be used as a means of transport between home and school. It should not be used for short trips out during the school day, for example during study periods and break or lunchtime, or as a focus for groups of students in the car park.
- 6 Students must not transport other students on motorcycles/scooters at school.
- 7 The school can accept no liability for any loss from or damage to the vehicle or gear, such as helmet, leathers, whilst on site.
- 8 Students must inform the Sixth Form of any change in vehicle during the period of their parking permit.
